

## **Our Work**

### Standing up for Kids: The Children's Task Force

Established in 2003, the Children's Task Force examines issues relating to Colorado's children to determine if there are legal problems that would benefit from the advocacy of Colorado Lawyers Committee volunteers. Volunteers have focused on expanding access to Medicaid benefits to children with autism. Currently, task force volunteers are working to ensure that the State provides behavioral therapy services to children with autism through Medicaid as required by federal law.











## Advocating for Better Education for Colorado's Students: The Education Task Force

The Lawyers Committee has a long history of advocating on education issues. Much of the Task Force's work during the last five years has focused on litigation (see, for example, the Amendment 23 Litigation). In addition, the Education Task Force is examining whether small school districts that fund their schools entirely through local property taxes can be required by the State to increase their mill levy without voter approval and write a check to the State for their share of the "negative factor" (which was implemented by the State to cut \$1 billion per year from education). Most recently, the task force has begun to explore the reasons for the apparent re-segregation of schools in Denver.

## Ensuring Adequate Funding for Education: Amendment 23 Litigation

In 2014, a group of volunteers challenged the State's funding of K-12 schools (*Dwyer v. State of Colorado*) alleging that the State's \$1 billion per year cuts to school funding since 2010 were a violation of Amendment 23 to the Colorado Constitution. In February 2015, after the district court had rejected the State's motion to dismiss, the Colorado Supreme Court accepted the case for review. In September 2015, the Court agreed with the State's objection and ordered the district court to dismiss the case.





## Ending the School to Prison Pipeline: The School Discipline Task Force

The School Discipline Task Force was created in 2014 to help address the school-to-prison pipeline resulting from the statewide criminalization of school discipline incidents. In 2015, the task force partnered with community advocates, legislators, and others to help pass House Bill 15-1273. The bill provides funding to collect and compile data on school discipline incidents which will be critical in assessing the ways in which student conduct has been over-criminalized. The task force will continue to monitor the implementation of this new law and the criminalization of schools.

### Imagining a New System: Redesigning Education

Since 2013, the Colorado Lawyers Committee has partnered with the Donnell-Kay Foundation to provide legal advice to the Foundation on its ReSchool Colorado initiative, an effort to model an entirely new state public education system in Colorado where learning is reimagined and students graduate equipped to thrive in a rapidly changing world. Colorado Lawyers Committee volunteers have worked with the Foundation to explore ways to overcome legal obstacles to this new system.

## **Voting ID Subcommittee**

In November 2015, the Lawyers Committee created a new task force to explore possible consequences if Colorado ever enacts more restrictive voting ID requirements (as some other states have done). More than 45 lawyers have signed up to explore whether such restrictions might disenfranchise significant numbers of individuals (mostly poor and elderly) who are unable to obtain a stateissued ID. The subcommittee is exploring litigation and voting requirements in other states and the availability of data in Colorado to measure the number of people who do not have state-issued IDs and would not be able to vote. The subcommittee expects to issue a preliminary report in late summer.

### Nonpartisan Election Call Center

For ten years, the Colorado Lawyers Committee has been an active participant in a coalition (Just Vote! Colorado) which sponsors a Nonpartisan Election Call Center. In 2014, 60 Lawyers Committee volunteers spent over 200 hours responding to questions from more than 500 voters around the state related to voting, polling places and other issues. Plans for the 2016 call center are underway and volunteers will answer calls on Election Day and for four or five days during early voting.

## Teaching Students about Hate Crimes: The Hate Crimes Education Task Force

For more than 20 years, volunteers have presented an education program on Colorado's Hate/Bias-Motivated Crimes Statute to schools and community groups around the state. Using a fictional trial format involving a high-school student charged with hate crimes against a Muslim teacher, a perceived LGBT student, and others (including by way of social media threats), the presentation empowers student participants to act as jurors to improve their community culture in areas concerning diversity, discrimination, stereotypes, and preventing the severe harm caused by hateful slurs and biased actions. Volunteers have conducted more than 60 educational trials in the last five years. In early 2016, the task force partnered with the Department of Justice in its efforts to reach out to minority communities (particularly those with significant Muslim presence) and will offer presentations in at least five schools. The task force also recently conducted a training attended by more than 30 new volunteers.

## Defending Landowner Access to the Taylor Ranch: The Taylor Ranch Task Force

The Taylor Ranch litigation (Lobato v. Taylor) involves the right of landowners in the San Luis Valley to access a 77,500 acre mountainous parcel known as the Taylor Ranch. This right was created in the mid-1800s when settlers on the Sangre de Cristo Land Grant, then a part of Mexico, were promised access to the mountainous regions near their homes for uses necessary for their survival. More than 100 years later, Jack Taylor purchased and fenced off the land. The Lawyers Committee has been active in this litigation for almost 20 years and is still identifying landowners entitled to access the property (after a 2003 decision by the Colorado Supreme Court upheld the rights of plaintiff property owners). To date, the District Court has examined title to thousands of parcels of land and found that all but a few parcels are entitled to access Taylor Ranch. In 2014, the team successfully challenged an attempt by the owners of the Taylor Ranch to deny access to approximately 25 landowners in Los Vallejos area. In 2015, the team reached a landmark stipulation with the owners of the Taylor Ranch regarding the scope of lands entitled to access, resulting in hundreds of additional parcels obtaining access rights. The team also defeated the ranch-owners' attempt to limit access-holders' use rights through motions filed in the District Court.

## Protecting the Rights of Individuals With Mental Health Challenges: the Jail Wait Litigation

This lawsuit arose from a 2006 action against the State Hospital in Pueblo alleging it failed to timely admit mentally ill individuals who were waiting in Colorado jails for competency examinations which the Hospital had been ordered to conduct. The initial lawsuit was resolved with a court approved settlement that required the Hospital to conduct examinations within 24 days of receiving the court orders to evaluate these individuals. When the settlement expired in 2009, the Hospital stopped providing evaluations within 24 days and the "jail wait" times increased significantly. In August 2011, volunteers filed a federal civil rights action representing the Legal Center for People with Disabilities and Older People (now Disability Law Colorado) against the State of Colorado's Department of Human Services and the Colorado State Mental Health Hospital in Pueblo, alleging 14th Amendment constitutional violations. A landmark settlement was reached in 2012, with an agreement that requires the State to evaluate individuals for competency in the county jails within 30 days of receipt of the court order and essential police reports. It also forces the State, within 28 days of receiving the court order and essential police reports, to admit to the State Hospital in Pueblo those individuals who have been ordered to have competency examinations in the State Hospital and those already found incompetent and awaiting treatment. In 2015, the Federal District Court agreed to reopen the case, after the plaintiff alleged that the State was in violation of the settlement agreement. The parties have agreed to proceed to mediation to explore resolution of their differences.

# Exploring Transformation of the Criminal Justice System: the Criminal Justice Task Force

This task force grew out of the Sixth Amendment Task Force which successfully challenged the Colorado statute that required individuals charged with a misdemeanor to meet with the prosecutor before they could have a lawyer appointed to represent them. The task force recently turned its attention to exploring possible improvements to the treatment by the criminal justice system of those with mental health challenges.













### Helping Indigent Individuals Obtain IDs: The Joint ID Task Force

There are major barriers in Colorado to obtaining a state-issued identification card (ID), particularly for those with limited resources. Since 2006, the Colorado Lawyers Committee has worked to address the barriers facing homeless and other individuals in obtaining



Colorado IDs, without which they are unable to secure housing, employment and other critical services. In early 2013, at the request of the Lawyers Committee, Governor Hickenlooper's office created a Joint ID Task Force. Participants include representatives from the ID Collaboration Project (housed at Colorado Legal Services), at least six staff from the Department of Revenue (DOR) (including the Executive Directors and Deputy Directors of the DOR and the Division of Motor Vehicles) and the Executive Director of the Lawyers Committee. Individuals from the Department of Corrections, the American Immigration Lawyers Association and other organizations are invited, as appropriate, to attend monthly meetings where individual issues and systemic barriers to obtaining IDs are discussed. In 2015, significant issues included limiting barriers to obtaining gender changes on licenses and IDs for transgender individuals, expediting applications through SB13-251 (the legislation that permits the issuance of drivers licenses and IDs to undocumented individuals and to those who are temporarily in the country legally), and expanding "exceptions processing" for individuals who cannot provide adequate documentation when requesting a license or ID. In early 2016, the Lawyers Committee successfully supported legislation (HB16-1386) that provides funding for low-income Coloradans to secure documents needed to obtain Colorado IDs.





### Legal Clinics for the Underserved: Greeley Legal Night

Greeley Legal Night was established in 2009, as a joint project of the Colorado Lawyers Committee and the Spanish Speaking Lawyers Association of the Colorado Bar Association. Since 2010, the Task Force has run a legal clinic every other month at Our Lady of Peace Church in Greeley. Modeled after the successful Denver Legal Night program, volunteer lawyers provide free legal information and referrals to a community where such resources are limited; volunteer interpreters also are available when needed. Issues addressed typically include immigration, family, housing and criminal matters. Since the start of the clinic, more than 2,000 individuals have been assisted by Task Force volunteers from the Denver-metro and Weld County legal communities. In 2015, over 120 clients were served.

### Legal Clinics for the Underserved: Denver Legal Night

Since 2006, the Colorado Lawyers Committee has co-sponsored, with the Denver Bar Association Young Lawyers Division and the Denver Access to Justice Committee, two monthly Legal Night clinics to provide legal information and referrals for individuals and families who can't afford legal services. Clinics are held at Centro San Juan Diego and Mi Casa Resource Center and clients are served on a first-come first-served basis. Issues generally include immigration, criminal, family, consumer, and housing matters; volunteer interpreters also are available to assist when needed. In 2015, the Lawyers Committee co-sponsored continuing legal education trainings in family law, helping more than 75 volunteers become better equipped to help individuals with family law concerns at Legal Night. Since Denver Legal Night began, more than 21,000 individuals have been served. In 2015 alone, volunteers assisted 2,319 clients.

### **Project Homeless Connect**

Since 2005, the Lawyers Committee has coordinated the legal component for Project Homeless Connect, a one-day event sponsored by the City of Denver which typically links about 1,000 homeless individuals in Denver to a variety of services, including public benefits, housing, jobs, medical care, and legal assistance. Task Force volunteers staff a legal resource area, where homeless individuals receive legal information and referrals, as well as a Homeless Court, where outstanding warrants for municipal violations can be resolved before a Denver County Court Judge. Since 2010, the Task Force has provided 829 legal volunteers to these events, more than 2,600 individuals have been helped with legal issues, and more than 1,300 cases have been heard in the Homeless Court. In 2015 the event was cancelled due to inclement weather but has been rescheduled for November 3, 2016.

## Ensuring Proper Benefits Processing: CBMS Litigation

More than ten years ago, Colorado implemented a new computer system to streamline the processing of public benefits (the Computer Benefit Management System). From the beginning, the new system improperly denied or delayed essential public benefits, resulting in serious and life-threatening problems for Colorado citizens. In 2004, members of the Task Force obtained a court order requiring the State to substantially improve benefit processing and the case was subsequently settled. The team continues to monitor the State's compliance with Federal law and the requirements of the settlement.

## Protecting Nutritional and Medical Benefits: Public Benefits Task Force

This Task Force was created in 2008 to examine the delay in processing Food Stamp applications in certain Colorado counties. As a result of the Task Force's negotiations with Denver, the County completely overhauled its procedures for processing food stamp applications, and improved its compliance rate with federally mandated timelines from 60%



to over 90%. In 2015, the task force challenged the State's failure to provide continuing benefits (Medicaid, Food Stamps, etc.) when a timely appeal is filed, as required by federal law. The task force's efforts resulted in significant changes in State procedures, guaranteeing due process for benefit recipients.

## Accessing Help for Medical Needs: Health Care for Community Corrections Residents

Every year, 4,000 individuals in Colorado's Community Corrections system (half-way houses) have severely limited access to health care. Until recently, the federal government asserted these individuals were not eligible for care under the Colorado Indigent Care Program or for Medicaid or subsidies under the Affordable Care Act. As a result, the only health care options for these individuals were treatment in emergency rooms or, for more serious medical needs like cancer or a problem pregnancy, reoffending and returning to prison to receive health care. At the task force's request, numerous officials (Representative DeGette, Governor Hickenlooper and Attorney General Suthers) asked the federal government to reevaluate its position. In early 2016, the federal government finally agreed that health care for individuals in community corrections is critical and that parolees and others in halfway houses who are financially eligible may obtain medical services through Medicaid.

## Systemic Legal Problems Related to Housing: The Housing Task Force

This Task Force was created in late 2013 to explore housing issues in Colorado that might benefit from legal advocacy by Lawyers Committee volunteers. To get a better understanding of the issues and to evaluate possible needs in Colorado, the team researched national housing issues and met with numerous local organizations and individuals. Although the task force identified significant issues in affordable housing, it concluded that the current solutions are political, not legal. The task force recently decided to suspend its activities until systemic legal issues can be identified.

### Assisting Small Colorado Nonprofits: the Nonprofit Pro Bono Matching Program

Since 2009, this Task Force has, in partnership with the Colorado Nonprofit Association, provided transactional-type legal services and representation to budget-constrained nonprofit organizations. While the Task Force initially assisted only nonprofits that serve children or the indigent, in 2010, the Task Force broadened the scope of its work to include all small nonprofits whose operating budgets do not permit them to retain legal counsel. Last year, volunteers provided transactionaltype legal assistance to over 70 organizations. Since the matching program began, more than 300 nonprofits have been served.

### Nonprofit Legal Audit Clinic

Since 2006, the Colorado Lawyers Committee has co-sponsored a nonprofit Legal Audit Clinic for small nonprofits with limited operating budgets. Teams of transactional attorneys review a checklist with participating nonprofits to evaluate their legal health. Client meetings are preceded by a CLE training for participating lawyers on Colorado nonprofit law. At the clinic on January 21, 2016, forty volunteers provided legal audits for 19 nonprofits.

## Assistance for Indigent Immigrants: The Immigration Task Force

For almost 20 years, the Colorado Lawyers Committee has supported the efforts of the San Luis Valley Immigrant Resource Center to provide low cost immigration services to the local population, including overseeing services provided, training its staff, and providing referrals to pro bono attorneys. This year, the task force continued its assistance to IRC and also helped to provide guidance to individuals at Legal Night seeking assistance with Colorado Senate Bill 13-251, which authorizes the issuance of a Colorado driver's license, instruction permit or identification card to those individuals who either cannot demonstrate lawful presence in the U.S. or can only demonstrate temporary lawful presence. Other areas of interest at Legal Night were questions regarding the influx of unaccompanied children coming to the U.S. and the anticipated expansion of the executive orders about Deferred Action for Childhood Arrivals and Deferred Action for Parents of Americans.

## **Immigration**

### Helping Immigrant Children: Training on SIJS for Non-Immigration Lawyers

In response to the humanitarian crisis involving unaccompanied immigrant children in Colorado



and the dire need for pro bono legal representation for this vulnerable population, the Colorado Lawyers Committee partnered with the Rocky Mountain Immigrant Advocacy Network (RMIAN), and Brownstein Hyatt Farber Schreck, LLP to present a free training on March 16, 2016 on Special Immigrant Juvenile Status (SIJS). SIJS is a legal immigration protection for immigrant children who have been abused, abandoned, or neglected and who are juvenile court dependents. Through this form of immigration relief, children have the opportunity to become lawful permanent residents and start their lives anew. Many children currently in proceedings before the Denver Immigration Court are eligible for this form of protection, but lack counsel to represent them, in both juvenile/state and immigration proceedings. More than 40 people attended this training. The attorneys in attendance agreed to take a pro bono case representing an immigrant child.


